# Goal of Community Support Funding Program

The goal of the Community Support Funding program is to create opportunities for organizations to work in partnership with the City to develop and support innovative and sustainable programs/services that address City Council goals.




### Types of Funding

- Contractual funding
  - ► City contracts with another agency for specific services
    - ► Examples: Dogs at large are taken to the Animal Shelter, Police make referrals for mental health or detox services
- Discretionary funding
  - ► City funds programs and services offered to City residents by nonprofit organizations under a block grant system
    - ► Examples: Financial incentives offered to new businesses, support for social service programs

# **Discretionary Funding**

FY2019 Community Support Funding Requests



### Organization Eligibility

- Applicants must be:
  - ☑ Local provide services within the City limits
  - ✓ IRS-certified Non-Profit Organization
  - ✓ In good standing
- Must adhere to the City's Code of Ethics/Code of Conduct
- Must be able to demonstrate good financial management
  - Provide recent results of an independent financial review
  - Adopted annual budget
  - ☑ Copies of latest financial statement, including income and expense statements
  - ☑ Copy of either a balance sheet or statement of net assets



### Program Eligibility

- Program/service must target City residents
- Organization should not already receive funding from the City for the same program through another mechanism or other block grant
- Funding request should be consistent with City Council goals
- Request may be for block grant type funding (grants given to one organization that benefit multiple organizations through partnerships or sub-grants)
- Funding requests for operational support will not be considered
- Administrative costs allowed based on a formula

\$5,000 - \$9,999 Up to \$1,000	
\$10,000 - \$50,000 Up to \$5,000	
\$50,001+ Up to \$5,000 + 5% of block §	grant

### **Application Submission**

- ► APPLICATIONS ARE DUE TUESDAY, JULY 31st BY 4:30 PM
- Application Packet (Must be included as a single PDF)
  - Completed Application
  - ☑ Copies of latest financial statements, including income and expense statements
  - Copy of either a balance sheet or statement of net assets
  - ☑ Copy of latest results of an independent financial review or financial audit
  - ✓ Project Line Item Budget (if not included in application)
  - ☑ Other information about your organization (optional)



### **Evaluation Process**



#### **Evaluation Process**

- Applications will be reviewed and scored by an review committee
  - City staff and community member(s)
- ► Total of 6 evaluation criteria and 100 possible points
- Applicants will be evaluated solely on the submitted application packet
- Committee's recommendation and supporting documentation will be presented to the City Manager
- Recommended applicants will present to City Council in October

# Evaluation Criteria #1 Basic Requirements (5 points)

#### **Explanation**

Application is complete and meets all the requirements of the Community Support Funding program. Applicant is eligible.



# Evaluation Criteria #2 Community Impact (20 points)

#### **Explanation**

Proposal addresses a problem or fills an unmet need for which the City has purview. Does not duplicate efforts by another organization or address needs that are under another organization's purview. There are clear, realistic, measurable goals for program. If the organization has previously received Community Support funding, they can demonstrate good performance consistent with Council goals.



# Evaluation Criteria #3 Aligns with City Council Goals (20 points)

#### **Explanation**

Proposal helps the City of Durango achieve one or more City Council goals.

# Evaluation Criteria #4 Innovation and Community Leadership (20 points)

#### **Explanation**

Organization demonstrates outstanding leadership in the community through innovation, ethical standards, competency in their field of expertise, and partnership with other community organizations (including the City).



# Evaluation Criteria #5 Sustainability (15 points)

#### **Explanation**

The organization has a diverse funding base. City of Durango is not the sole funder of the program/service (exception for pilot programs). Identifies and pursues opportunities for partnerships in program delivery. Can demonstrate adequate operational reserves and long-term financial and operational stability.



# Evaluation Criteria #6 Organizational Capacity (20 points)

#### **Explanation**

Organization demonstrates sound financial management as evidenced through adopted financial policies, board oversight, and independent financial review. Board members and executive director are stable and receive training and professional development. Strong possibility that the organization can complete the project successfully.
